The September program will be a demonstration of techniques in weathering and detailing cars by Barrett Johnson and Bill Boyle. Members who wish may bring a car to weather. There will be a written handout covering the basics.

## Minutes of May 2006 BBMRA Membership Meeting

The May 16, 2006 membership meeting was called to order by Vice President Randy Lombardo at 7:30 p.m. in the Community Room at Myers Park. Twenty-eight (28) members were present.

**Minutes:** Minutes of the April 18, 2006 meeting, as published in the May issue of *The Lantern*, were approved unanimously.

### Division Reports:

### **PURPOSE OF MEETING**

The main purpose of this Board Meeting was to discuss and adopt this year's budget. After a lengthy discussion, a motion was made to adopt last year's budget, with a separate budget item of \$100.00 to be subtracted from Miscellaneous for Awards. Motion was seconded and passed unanimously. An additional motion was made for the Board to meet again Mid-year to make any revisions to this year's budget that may be necessary. Motion was seconded and passed unanimously.

Bill Boyle is to draft this year's budget and present it at our next Membership meeting.

Garth Easton brought to our attention that using the Web site more would make the cost of the site cheaper and help our budget.

### **ADDITIONAL TOPICS**


A discussion was held and decision made to allow any scouts in uniform into the Show free.
